# Chabot Las Positas Association of Retired Employees Board Meeting March 7, 2016

## CALL TO ORDER

Tenbrink called the meeting to order at 11:05 a.m.

## APPROVAL OF MINUTES

The October 12, 2015, minutes were approved with the following corrections, under the Newsletter heading, change December to November; under the Activities Report heading, change 12 p.m. to 12:45 p.m. and 1:30 p.m. to 11:45 a.m., and under the Communications Director Report heading, change 100 to 200.

# DEVELOP PLAN OF ACTION, 2016 AND BEYOND Logistics of New Member Engagement

Tenbrink reiterated his thoughts on how to engage new members to join CARE and participate in CARE activities.

Trethan shared the following data on membership from 2005 to 2014:

- 475 members
- 205 have never paid dues
- 110 stopped paying dues
- 64 lifetime members
- 124 paid members in 2015
- 51 paid members to-date in 2016

She has created a list of names and the last time they paid membership dues as well as a list of lifetime members. She is not always able to obtain retirees' addresses from the district and therefore must use her personal resources to get this information.

She shared data on the number of retirees from 2007 to 2015:

- 2007 14
- 2008 25
- 2009 49
- 2010 04
- 2011 36
- 2012 11

- 2013 09
- 2014 19
- 2015 24

Tenbrink reviewed the procedures used to contact recent retirees:

- The CARE President writes a letter to the retiree. He provided a draft of a revised letter.
- Threlfall follows up with an email and reiterates what was said in the President's letter. In some instances, this email may precede the letter.
- A board member will follow up personally with the retiree.

Furthermore, at the Chabot College campus, contact is made with the retirees at the annual retirement event and at the Las Positas College campus Tenbrink has made contact at the commencement ceremony.

After some discussion, Tenbrink proposed the CARE Board seek to increase paid membership by approximately 5%, 5 new paid members and to increase attendees to the annual luncheon by approximately 10%, 5 new attendees

#### **Role of Board Members**

Plunkett presented her thoughts on the role of board members. She suggested that the board members have a discussion on how to sharpen the image of CARE. She proposed that the board consider having name tags to wear at functions that would identify them as a member of the CARE board. She provided an example of attending John Sims retirement party and that having a name tag would have been a way to identify the presence of CARE.

M/S/P (Threlfall.Neu) that Plunkett be authorized to investigate the purchase of name tags and to allocate an expenditure of two hundred dollars (\$200).

She further proposed developing a nonfinancial relationship with the Chabot College Foundation and its Executive Director, Maria Ochoa, as well as to continue to maintain relationships with staff at both campuses and the district.

The outreach committee was formed and Plunkett, Bridge, Maldonado Aziminia, Trethan, and Wiseman will serve on the committee.

# **CARE Grant Funding Commitment 2016-17**

Threlfall reported that funds for CARE grants are from the CARE Funds and not from the CARE membership dues. Wiseman recommended that the interest from the CARE Funds be used to fund the grants. This amount is approximately \$2,500. Threlfall was directed that the expenditures for the CARE grants are not to exceed the interest of the CARE funds and to confirm this amount with Wiseman. The CARE committee members are: Threlfall, Chair; Tenbrink, President; Plunkett, Vice President; Wiseman, CARE Fund; and Gerrits.

# Vacancy of Las Positas Liaison

Tenbrink has approached Gilberto Victoria to serve as the Las Positas liaison. He will keep the board apprised of Victoria's possible agreement to serve on the board. Plunkett reported that a possible liaison for Chabot is Jane Vallely. Any recommendations to serve on the Board are to be emailed to Tenbrink.

# **Changes in CLPCCD Board Policy**

A discussion ensued on Board Policy 7380 and the changes that are being proposed to clarify the language that was approved on August 15, 2015.

M/S/P (Threlfall/Neu) that the CARE Board authorizes the committee consisting of Tenbrink, Threlfall and Trethan to contact Chancellor Jannett Jackson to seek revision of Board Policy 7380, Retirees Health Benefits.

M/S/P (Threlfall/Bridge) that the CARE Board authorizes the committee consisting of Tenbrink, Threlfall and Trethan to approach members of the Board of Trustees if the committee is not able to resolve the policy with Chancellor Jannett Jackson.

# 2016 Reunion Debriefing

Tenbrink reported that the 2016 Reunion Luncheon held on January 22 was a success and that all in attendance enjoyed the event. The next luncheon will be held on January 21, 2017. Threlfall proposed that the board may what to consider another venue that may be more appealing to the CARE membership. Tenbrink advised the board to send any ideas to Activities Director, Connor.
